To send these notifications, you must specify the SMTP server to be used for forwarding the e-mail messages. To configure e-mail options in the console tree, right-click File Server Resource Manager, and then click Configure options. The File Server Resource Manager Options dialog box opens.

On the E-mail Notifications tab, under SMTP server name or IP address, type the host name or the IP address of the SMTP server that will forward e-mail notifications.

If you want to routinely notify certain administrators of quota or file screening events, under Default administrator recipients, type each e-mail address.

Use the format [\[email#160;protected\]](#) Use semicolons to separate multiple accounts.
